Application for the City of Lethbridge 2018 interim transmission facility owner tariff, effective January 1, 2018

Proceeding 23009 City of Lethbridge

The Alberta Utilities Commission, the independent utilities regulator, will be considering the application for the City of Lethbridge's 2018 interim transmission facility owner (TFO) tariff to ensure that the delivery of Alberta's utility service takes place in a manner that is fair, responsible and in the public interest. If you feel you may be affected by this application, you can provide input to the AUC to review before it makes its decision.

The City of Lethbridge 2018 interim TFO tariff application applies to transmission facilities owned by the City of Lethbridge and operated by the City of Lethbridge Electric Utility Department, collectively referred to as "LEU."

LEU is currently preparing a full general tariff application to be effective on a final basis on January 1, 2018. It is unlikely that a final tariff will be approved in advance of January 1, 2018. Therefore, LEU is requesting approval to continue the currently approved 2017 tariff on an interim and refundable basis until such time as the AUC approves either a revised interim and refundable tariff or a final tariff. LEU's current approved 2017 monthly tariff of \$593,460 was approved in Decision 22136-D01-2016.

If you feel you may be affected by this application, you can provide input to the AUC to review before it makes its decision.

Written submissions are due October 20, 2017.
