ATCO Electric Ltd. New Transmission Line 7LA65	Proceeding 23110 Application 23110-A002

ATCO Electric Ltd. (ATCO Electric), pursuant to Permit and Licence 21643-D04-2016,¹ has approval to construct and operate a 144-kilovolt (kV) transmission line designated as 7LA65 from Steele 2016S Substation to transmission line 7L65 in the Mannville - Vermilion area.

ATCO Electric, by Application 23110-A002 registered on November 17, 2017, applied to the Alberta Utilities Commission for approval of a time extension beyond the previously approved date of December 31, 2017, in order to complete the transmission line.

The Commission, pursuant to sections 14, 15 and 19 of the *Hydro and Electric Energy Act*, approved the application in Decision 23110-D01-2017² and granted to ATCO Electric a permit to construct and a licence to operate the transmission line, subject to the provisions of the *Hydro and Electric Energy Act* and the *Alberta Utilities Commission Act*, any regulations made under the acts, any orders made under the acts, the Commission rules made pursuant to the *Alberta Utilities Commission Act*, and the following terms and conditions:

1. The route of the transmission line shall be as shown on Appendix A and as described in Application 21643-A003.
2. Temporary workspace areas shall be set up at the locations listed in Appendix B and as described in Application 21643-A003.
3. Permanent access trails shall be constructed at locations listed in Appendix C and as described in Application 21643-A003.
4. Specifications of the transmission line shall include the following:
 - a) The transmission line shall be designed, built for and operated at a nominal voltage of 144 kV.
 - b) The structures shall be constructed of materials as specified in Application 21643-A003 and other previous approvals pertaining to the transmission line.

- c) Other aspects of the transmission line as more particularly described in Application 21643-A003 and other previous approvals pertaining to the transmission line.
5. ATCO Electric shall file with the Commission within 30 days of completing the transmission line, the energization certificate(s) for the transmission line issued by the Alberta Electric System Operator and/or by ATCO Electric, to confirm that the transmission line has been completed and the transmission line is being operated in accordance with the provisions of this permit and licence.
 6. Unless otherwise authorized by the Commission, the transmission line shall be completed by September 15, 2019, or a later date of March 15, 2020 subject to ATCO Electric filing an approval by the Alberta Electric System Operator of a change proposal for the later in-service date.

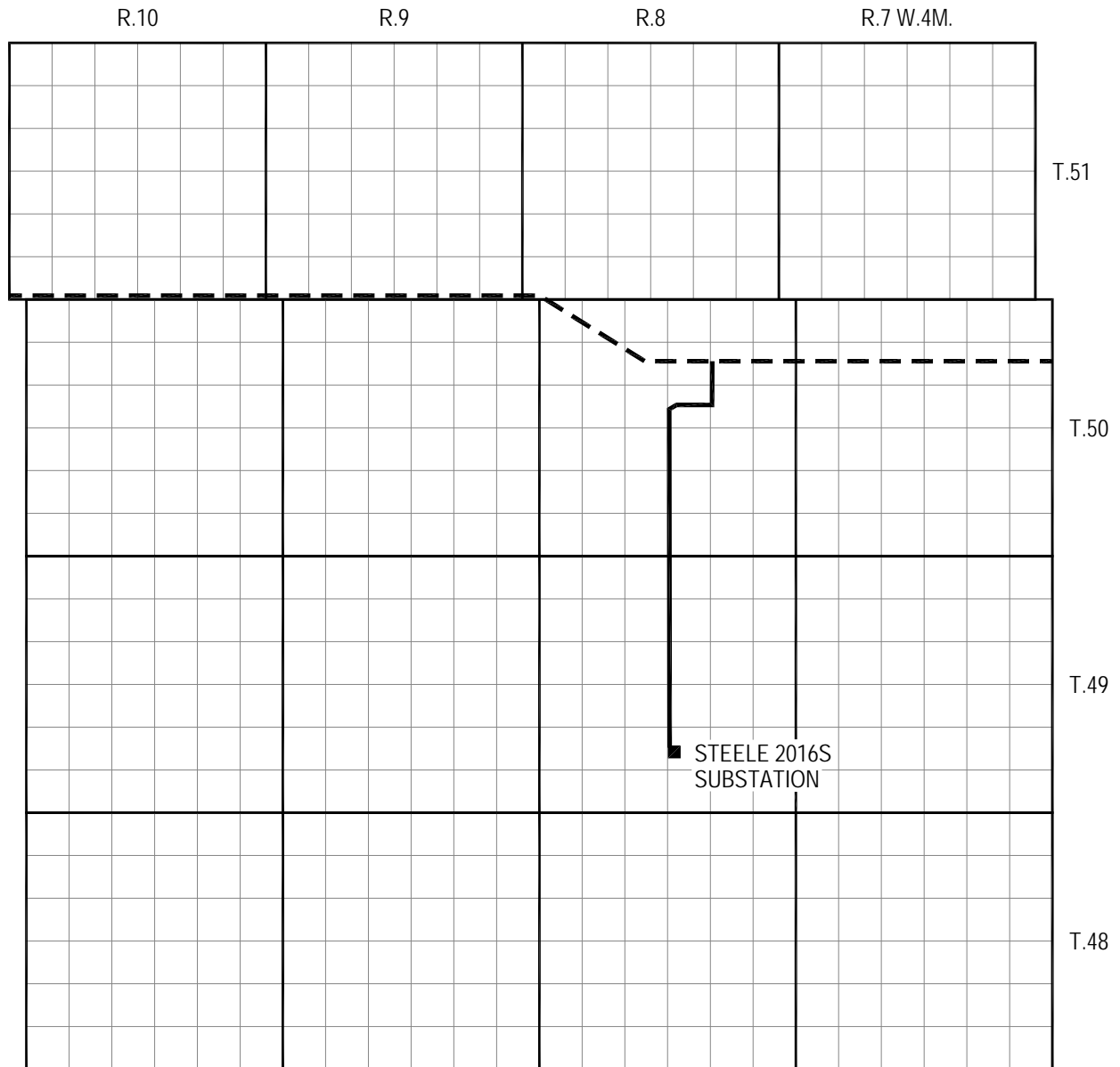
Permit and Licence 21643-D04-2016 is rescinded.
