ATCO Gas and Pipelines Ltd. (ATCO) applied to the Alberta Utilities Commission for an amendment to Licence 2526 for the following:

- splitting line 8 into lines 8, 213 and 214
- removal of line 213

The Commission amended Licence 2526 under Section 11 of the *Pipeline Act*, and Section 4.1 of the *Gas Utilities Act* in Decision 22902-D01-2017<sup>1</sup> subject to the provisions of the *Pipeline Act*, *Gas Utilities Act* and the *Alberta Utilities Commission Act*, any regulations or orders made under the acts and the Commission rules made pursuant to the *Alberta Utilities Commission Act*.
