

# Power Plant Approval 23037-D02-2018

PetroChina Canada Ltd. Time Extension to construct an 85-MW Cogeneration Power Plant	Proceeding 23037 Application 23037-A001

PetroChina Canada Ltd. (PetroChina), pursuant to Approval 22935-D03-2017,<sup>1</sup> has approval to construct and operate an 85-megawatt (MW) cogeneration power plant located in the Athabasca oilsands region. The construction completion date for the power plant was stipulated to be on or before December 31, 2017.

PetroChina, by Application 23037-A001, registered on October 23, 2017, applied to the Alberta Utilities Commission for approval to extend the completion date of the power plant to December 31, 2025.

The Commission, pursuant to sections 11 and 19 of the *Hydro and Electric Energy Act*, approved the application in Decision 23037-D01-2018,<sup>2</sup> and granted to PetroChina an approval to construct and operate the power plant, subject to the provisions of *Hydro and Electric Energy Act* and the *Alberta Utilities Commission Act*, any regulations made under the acts, any orders under the acts, the Commission rules made pursuant to the *Alberta Utilities Commission Act*, and the following terms and conditions:

1. The power plant shall be located in Legal Subdivision 5 of Section 12, Township 90, Range 14, west of the Fourth Meridian, as further described in the Application 1608469.
2. The power plant shall consist of one unit with a total generating capability of 85 MW and as further described in Application 1608469.
3. PetroChina shall submit a construction progress report to the Commission in writing, once every six months, pursuant to Section 3 of the *Hydro and Electric Energy Regulation*. The first progress report shall be filed with the Commission six months from the date of issuance of this approval.
4. PetroChina shall notify the Commission within 30 days of completing construction of the power plant.
5. Unless otherwise authorized by the Commission, construction of the power plant shall be completed by December 31, 2025.

6. PetroChina shall obtain Commission approval prior to making any substantive changes to the power plant or substantially varying the design or specifications of the power plant from what was stated in Application 1608469 or from what the Commission has approved.

7. This approval is not transferable unless approved by the Commission.

Approval 22935-D03-2017 is rescinded.

The Commission may cancel or suspend this approval, in whole or in part, in accordance with Section 41 of the *Hydro and Electric Energy Act* or may review this approval, in whole or in part, upon its own motion or upon an application by an interested party, in accordance with Section 10 of the *Alberta Utilities Commission Act*.
