ATCO Gas and Pipelines Ltd. applied to the Alberta Utilities Commission for an amendment to Licence 11239 for the following:

- splitting line 1 into lines 1, 4 and 5
- removal of line 4
- addition of newly constructed pipeline (line 6 – 0.05 kilometres of 406.4-millimetre outside-diameter pipeline)
- addition of newly constructed pipeline (line 7 – 0.05 kilometres of 406.4-millimetre outside-diameter pipeline)

The Commission amended Licence 11239 under Section 11 of the *Pipeline Act*, and Section 4.1 of the *Gas Utilities Act* in Decision 24728-D01-2019¹ subject to the provisions of the *Pipeline Act*, *Gas Utilities Act* and the *Alberta Utilities Commission Act*, any regulations or orders made under the acts and the Commission rules made pursuant to the *Alberta Utilities Commission Act*.
