ELECTRIC ENERGY CHARGES – JULY 2009
APPLICATION NO. 1605205**

1. Direct Energy Regulated Services (DERS), a Business Unit of Direct Energy Marketing Limited, filed an application (Application) on June 24, 2009, with the Alberta Utilities Commission (AUC) for its energy charges applicable to its Regulated Rate Tariff (RRT) for the month of July 2009.
2. The Application included a letter from the independent advisor¹ (the Advisor) stating that he had reviewed the energy charges filed by DERS for the month of July 2009, and concurred that they were calculated in accordance with DERS' 2006-2011 Energy Price Setting Plan (EPSP). DERS also filed signed copies of Certifications of Compliance from the consultation party representatives, the Advisor and DERS stating that the procurement of regulated rate supply for June 2009 was done in accordance with the EPSP.
3. DERS' proposed energy charges for the month of July 2009 are as follows:

Residential	8.824
Commercial	8.967
Industrial	8.634
Farming (Includes REA)	8.923
Irrigation (Includes REA)	8.643
Oil & Gas	8.559
Lighting	5.013

¹ The Advisor assisted in designing the 2006-2011 energy price setting plan (EPSP) and has an ongoing role respecting the procurement of the energy under the protocols established in the EPSP.

4. AUC staff members have reviewed the Application, including the letter from the Advisor, and the AUC accepts that the above noted energy charges represent rates determined in accordance with the DERS' EPSP approved by the AUC's predecessor, the Alberta Energy and Utilities Board (Board), in Order [U2006-108](#).² The EPSP formed part of a Negotiated Settlement, which the Board considered would result in rates that were just and reasonable.

5. DERS has included the 2009 pretax return margin of \$2.46/MWh in the July 2009 energy charge calculation in accordance with the AUC letter dated November 3, 2008. In Decision [2006-107](#),³ the Board directed DERS to update the pretax return margin each year by applying the forecast income tax rate to the Board approved after-tax margin of \$1.75/MWh.

6. In accordance with section 7(3) of the *Regulated Rate Option Regulation*, AR 262/2005, as amended (the RROR), the AUC acknowledges that the energy charges as set out above are applicable to DERS' RRT for the month of July 2009.

7. Further, as outlined in RROR sections 7(4) and 7(5), DERS must retain records sufficient to enable the AUC to audit any previous monthly rates set by DERS. Any amount overcharged to customers due to an incorrect rate calculation must be refunded to customers as soon as practicable after the error is discovered.

8. If any affected party objects to the calculation of the energy charges for the month in question, they should notify the AUC and DERS in a timely manner, and include the nature of their objection and the reason(s) why it should be considered.
