Apex Utilities Inc.
Third-Party Transportation Rate – January 2021
Proceeding 26202

1. Apex Utilities Inc. (AUI)¹ submitted its monthly filing on December 18, 2020, to the Alberta Utilities Commission for its proposed third-party transportation rate (TPTR) for the month of January 2021. The proposed TPTR was \$0.320 per gigajoule (GJ).
2. The AUC has reviewed the filing and considers that the proposed TPTR was determined in accordance with the method approved in Decision 2007-079,² as issued by the Alberta Energy and Utilities Board, predecessor to the AUC. Consequently, the AUC acknowledges for AUI the TPTR of \$0.320/GJ, which, as set out in Rate Rider G, is to be applied to the energy delivered to default supply and retail supply distribution service customers during January 2021.
3. Upstream transportation costs that are currently recovered through the TPTR were previously recovered through AUI's gas cost recovery rate (GCRR). Therefore, the Commission considers that, similar to the direction provided to gas utilities for GCRR applications in Decision 2001-75,³ interested parties shall be provided with a 30-day review period following the filing of each monthly TPTR in which to raise any concerns with the determination of the TPTR.
4. The Commission may, within 30 days of the date of this disposition and without notice, correct typographical, spelling and calculation errors and other similar types of errors and post the corrected disposition on its website.
